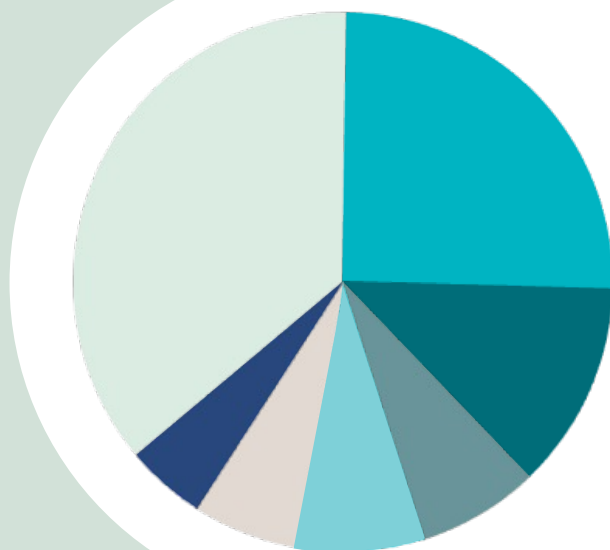
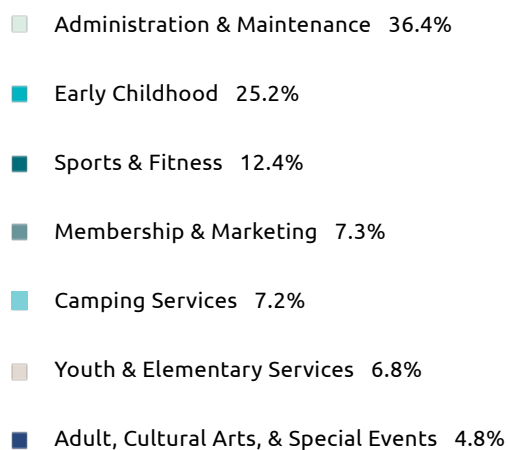
Total Revenue
