- Please turn in your registration materials during the appropriate registration Session listed below.
- Registration materials received before the appropriate Session will not be accepted and will be returned.
- **Session A (Wednesday, March 4 - Friday, March 13) Registration is open to children **currently enrolled** in Preschool and to their siblings.**
- **Session B (Monday, March 16 - Friday, March 20)**

**Weinstein JCC membership is a prerequisite.** Prior to the acceptance of this registration current membership dues and other program fees must be paid in full or be current with an approved Weinstein JCC payment plan. 2026-2027 Membership and other program fees must be paid in full by July 1, 2026 unless a payment plan has been confirmed with the Weinstein JCC Accounting Department. Fees may be charged on MasterCard, Visa or American Express or EFT (Electronic Funds Transfer). **Tuition payments will be made through Brightwheel and are due on the 1st of each month. Payments will start on August 1, 2026. You will receive an invoice once your monthly bill has been generated.** I understand the Center’s policy on Preschool registration and I agree to be responsible for payment of all fees due to the Weinstein JCC. I understand that failure to make payments as required will result in termination of service and collection action taken. In the event that collection action is taken, I understand that I will be responsible for any and all attorney and court costs incurred by the Weinstein JCC.
